

Data Sharing Terms

Effective Date: September 13th, 2019.

Introduction

The present terms and conditions, which shall be interpreted in accordance with the laws of Texas, apply to: data, information and editorial content contained in Intratec Indexes & Pricing Data ("Indexes & Pricing Data").

Glossary

In these terms and conditions:

"**Licensed Materials**" means the pricing data, price forecasts, market data, industry data, technology data and any other data, information and editorial content contained in Intratec Production Cost Reports, Extra Analyses, and/or Indexes & Pricing Data.

"**Subscriber**" means: individual, institutional or corporate subscriber of Indexes & Pricing Data identified in the Order Form.

"**Authorized User**" means: the named individual(s) identified in the Order Form and/or employees of an institutional or corporate Subscriber identified in the Order Form. Subscribers are responsible for ensuring compliance by the respective Authorized Users with these terms and conditions.

"**Derived Content**" means materials created by or on behalf of the Subscriber or Authorized Visitor, incorporating the Licensed Materials in combination with other information and/or data.

"**Unauthorized**" in relation to a person means any person other than an Authorized User or a Subscriber.

About Indexes & Pricing Data

Data, information, analyses and/or models presented in the Indexes & Pricing Data are prepared on the basis of publicly available information and non-confidential information disclosed by third parties. Third parties, including, but not limited to technology licensors, trade associations or marketplace participants, may have provided some of the information on which the analyses or data are based.

Use & Sharing

Subscriber or Authorized User may, in the course of its business, create Derived Content for internal use only, provided that; (i) the Subscriber or Authorized User acknowledges Intratec as a data source in relation to all Derived Content; and (ii) the Subscriber or Authorized User does not use or authorize the use of Derived Content in products that are competitive with Indexes & Pricing Data.

The Subscriber shall have a limited right in the ordinary course of its business to share data from Indexes & Pricing Data, on a confidential basis, according to the subscription plan, as follows:

Standard Plan. The Subscriber of a Standard Plan is allowed to share, on a confidential basis, data from Indexes & Pricing Data exclusively with CO-WORKERS FROM THE SAME INSTITUTION OR CORPORATION AS THE SUBSCRIBER, who also work at the SAME COUNTRY of the Subscriber.

Pro Plan. The Subscriber of a Pro Plan is allowed to share, on a confidential basis, data from Indexes & Pricing Data exclusively with CO-WORKERS FROM THE SAME INSTITUTION OR CORPORATION AS THE SUBSCRIBER.

Business Plan. The Subscriber of a Business Plan is allowed to share, on a confidential basis, data from Indexes & Pricing Data with CO-WORKERS FROM THE SAME INSTITUTION OR CORPORATION AS THE SUBSCRIBER, and with UP TO FIVE THIRD PARTIES, provided that such sharing complies with all the following conditions:

1. The excerpt of Indexes & Pricing Data must be only a limited extract (i.e. an insubstantial amount of data provided only on an ad hoc basis);
2. The excerpt of Indexes & Pricing Data is provided only on a non-continuous basis;
3. The excerpt of Indexes & Pricing Data is not updated in accordance with a regular schedule;
4. Subscriber or Authorized User acknowledges Intratec as a source in relation to the excerpt of Indexes & Pricing Data, as follows:

"This information has been extracted from an Intratec Indexes & Pricing Data. Intratec has not seen or reviewed any conclusions; recommendations or other views that may appear in this document. Intratec makes no warranties, express or implied, as to the accuracy, adequacy, timeliness, or completeness of its data or its fitness for any particular purpose. Intratec disclaims any and all liability relating to or arising out of use of its data and other content to the fullest extent permissible by law."

5. Any data from Indexes & Pricing Data must be treated as confidential information by the third party receiving the data from the Subscriber and/or Authorized User, in such a way that under no circumstances the receiving party will disclose/share the data received;
6. The shared excerpt of Indexes & Pricing Data is not used in products or services that are competitive with Intratec reports and data.

The use of Indexes & Pricing Data for any purposes not expressly permitted by these terms and conditions would be subject to a separate additional license or agreement and additional or different fees or payment arrangements.

Passwords are for the personal use of the individual to whom they are issued and may not be made available to others for the purpose of using Indexes & Pricing Data. If Intratec suspects that a password is being used by an unauthorized person it may cancel the password.

The Authorized User further agrees to refrain from any general release of the information presented in Indexes & Pricing Data, so as to constitute passage of title into the public domain or otherwise jeopardize common law or statutory copyright.
